



CONTRIBUTION LICENSE AGREEMENT

"You" means the person or entity set forth below.

You hereby grant to AOA, and its successors and affiliates, a non-exclusive, sub-licensable, fully paid-up, royalty-free, worldwide, non-terminable, perpetual license, under all applicable intellectual property rights, to use, reproduce, perform, display, modify, extend, and make derivative works of, and propagate, make available, and distribute (directly or indirectly, via any mode of communication or medium known or unknown, through single or multiple levels of distribution, including via websites owned or controlled by AOA), Your Contributions in whole or in part. Aside from this license, You retain all right, title and interest in and to Your Contributions.

You represent and warrant that each of Your Contributions is Your original creation and is not infringing of any third party's intellectual property rights. Other than the foregoing, You provide Your Contributions to AOA on an "AS IS" basis, WITHOUT WARRANTIES OR CONDITIONS OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY WARRANTIES OR CONDITIONS OF MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE.

This Agreement and all related disputes shall be governed by the laws of Colorado, notwithstanding the choice of law rules of any jurisdiction. The terms of this Agreement shall apply to the successors and assigns of the parties. This Agreement is the entire agreement of the parties relating to its subject matter.
